<sup>1</sup> Students pay an additional half credit hour fee for each half credit hour of enrollment over 18.

<sup>2</sup> The recreation fee is a flat fee for four or more credit hours.

<sup>3</sup> The COTA fee goes to the Central Ohio Transit Authority for student bus passes.

<sup>4</sup> See detail of selected rates for Learning Technology Fees and Program Fees charged by certain programs: Animal Sciences - Art - Business - Computer & Information Science - Communication - Engineering - Education & Human Ecology - Environment & Natural Resources - Food, Agricultural & Environmental Science - Health & Rehabilitation Services - Music - Nursing - Psychology

<sup>7</sup> For non-resident students enrolled in an on-campus, site-based program taking exclusively Distance Learning (DL) courses during a term, the Distance Education Non-Resident Surcharge is \$1,795 per student per term.

<sup>8</sup> For non-resident students exclusively enrolled in a for-credit online degree or certificate program listed at Ohio State Online (<https://online.osu.edu/programs>), the Distance Education Non-Resident Surcharge is \$200 per student per term. ONL must be represented on ALL program/plan stacks.
